Well Drilling: Each well brings clean water to up to 500 people. We train community pump caretakers to maintain and repair their well hand pump.

BioSand Filters: These filters use gravel and sand to remove up to 99% of pathogens from water, making it safe to drink. This program benefited 10,210 persons.
