4c (Code:) (Expenses \$ 57,780 including grants of \$) (Revenue \$) Hygiene and Sanitation Training: We use a participatory method to help communities identify and make action plans for the simple things they can do to stop the spread of preventable diseases such as HIV/AIDS. This program benefited 11,579 persons.
